Park Facility Rental Guideline and ParkRules

Please read and review the guidelines below. Keep a copy for your records. Sign and return this with your rental application.

- Everything in the park and on trails is protected. The removal of or tampering with plants, animals or other park or trail property is not permitted. *Mischief Statute IC38-43-1-2*
- All Vehicles must stay on designated parking areas. No person shall operate any motorized vehicle, skateboard, or any other device upon any trail or outside the Designated parking area with the exception of persons with disability as defined by the American with Disabilities Act which will be allowed to operate specialized motorized equipment for their transportation.
- No person shall use a weapon or firearm on any park property.
- All pets must be on a leash and under the control of their owner. It is expected that you pick up after your pets. *Includes County Ordinance 91.01 Dog Control*
- Bicycles are only allowed on paved or crushed stone trails. No riding off of designated trails is permitted.
- Grills are provided at the park. Do not bring grills or start fires on park property.
- Fireworks are not permitted in parks or on trails.
- No littering. If you carry something into the parks or onto the trails, please carry it out when you leave. *Littering Statute IC35-45-3-2-1*
- No alcoholic beverages permitted (except by special permit only).
- Overnight camping is not permitted.
- Horses are not allowed on the grounds of parks or trails, managed by the Morgan County Park and Recreation Board.
- There shall be no vending or advertising without permission from the Morgan County Park and Recreation Board.
- Use of metal detectors is prohibited.
- Geocaches must be registered with Morgan County Parks and Recreation Department.
- Waverly: No Skateboarding is allowed.
- Individuals listed on the State of Indiana's Sex Offender Registry published and disseminated by the Indiana Criminal Justice Instituted are prohibited from all parks and other recreational areas within the Morgan County Parks and Recreation Department jurisdiction.
- No vehicle shall be left within the park or other recreation department areas after the location has been closed to the public. The registered owner of the vehicle shall be responsible for the vehicle being within any park or recreational area after the location has been closed to the public.
- Swimming is prohibited including access to the river from the park property.
- No person or entity shall solicit, advertise, sell or promote for sale any commercial product or event within the park. Distribution or posting of flyers, brochures or other written material is prohibited in any of the park and other recreational areas.
