## *Old Town Waverly Festival- September 26th and 27th*

This packet contains an application to be a craft vendor, festival rules and guidelines, and more information. For the purposes of the Old Town Waverly Festival, craft vendor applications will be reviewed by the festival committee and accepted or rejected, based on the following eligibility requirements:

- A) Craft vendors may exhibit and sell items that they have handmade, hand-built, homegrown, and have unique artistic qualities. These wares should be made by those occupying the booth.
- B) No manufactured or imported products are allowed for sale at the festival. All wares must be made by the exhibitors.
- C) Exhibitors actually displaying and participating in their craft while at the festival will be given a higher priority. For instance, if a vendor is selling paintings and also demonstrates painting, this would be welcomed.
- D) Craft vendors must complete and return a vendor application and \$30 fee by September 8, 2026.
- E) The \$30 booth fee must be returned in the form of a check made out to "Morgan County Parks and Recreation."
- F) Vendors must be able to operate realizing that there is no wifi, water, ice, or change available at the park.
- G) The products and wares produced by a craft vendor must be appropriate to a family-friendly event and may not contain any profanity, suggestive language, or intolerant statements.

# Please review and keep the following information for your records.

## More Information

- Vendors are expected to be set up throughout the entirety of the festival. **Hours run Saturday, September 26<sup>th</sup> from 10am-6pm and Sunday, September 27<sup>th</sup> from 11am-4pm.**
- Vendors may check in to the festival on Friday afternoon from 3pm-7pm to receive their assigned sites. Old Town Waverly Festival Committee will assign sites prior to check-in.
- Set-up can occur Friday between 3pm-7pm, or between 9am-10am on Saturday and Sunday at 10am-11am.
- Vendor vehicles must be moved out of the festival grounds during festival hours. We will ask that all vehicles be moved by 15 minutes prior to festival opening each day.
- Please be advised that while we will provide security during the festival hours and Saturday night, Morgan County Parks is not liable for your wares. Please secure them when you are not in attendance at your booth.
- At this time, we are unable to provide electricity, wi-fi, water, ice, or change. There is a gas station with an ATM and an ice machine within a few minutes' drive of the festival.
- Vendor fees can be sent as a check or money order made out to: Morgan County Parks. Please include "Waverly Fest" in the memo line.
- Craft vendors are those who have made or built their wares themselves.
- If you do not have a website or Facebook page, you may be asked to submit pictures of your display or wares.
- This event is rain or shine.
- Vendors must remove all trash and debris at the close of the event.
- This is a family-oriented, community event. Displays and products should be appropriate for all ages. No profanity, suggestive language, or products supporting intolerance towards another group will be allowed.
- **Applications are due by September 8, 2026.**

## Park Rules

- The sale or use of alcohol is not permitted at this event, unless sanctioned by the Morgan County Parks Department.
- Smoking is not allowed in any building or structure—including temporary structures during events.
- All pets must be leashed at all times and any waste must be immediately removed.
- Weapons, including firearms, may not be used at the park, excepting historical reenactments during park-sponsored programs.
- Fireworks and other projectiles are not permitted.
- Parking is only permitted in designated areas.
- No firebuilding is permitted, except by permit of the Morgan County Parks Department.
