All food vendors requiring electricity for the operation of their booths, trucks, carts, etc. must submit their voltage and total amperage needs for operating their appliances and equipment during the festival. Vendor setup locations will be assigned based on their listed electrical requirements.

All appliances including deep fryers, roasters, rotisseries, ovens, warmers, freezers, coolers, and other electrical equipment must be listed, along with their required volts& amperage.

More Information

- Vendors are expected to be set up throughout the entirety of the festival, unless special arrangement has been made with the festival committee. **Hours run Saturday, September 26th from 10am-6pm and Sunday, September 27th from 11am-4pm.**
- Vendors may check in to the festival on Friday afternoon from 3pm-7pm to receive their assigned sites.
- Set-up can occur Friday between 3pm-7pm, or between 9am-10am on Saturday and Sunday at 10am-11am. If you need accommodations outside of these times, please make these arrangements with Volitta at volitta@morgancounty.in.gov.
- Vehicles must be moved out of the festival grounds during festival hours. We will ask that all vehicles be moved by 15 minutes prior to festival opening each day.
- Please be advised that while we will provide security Saturday night, Morgan County Parks is not liable for your site or its content. Please secure your area when you are not in attendance.
- At this time, we are unable to provide Wi-Fi, ice, or change. There is a gas station with an ATM and an ice machine within a few minutes' drive of the festival.
- The \$50 food vendor fee can be sent as a check or money order made out to Morgan County Parks.
- All food vendors are responsible for any/all permits needed for food service. For information obtaining a permit and guidelines for nonprofit waivers, please visit www.morgancountyhealth.com/environmental-health/food-division.
- If you do not have a website or Facebook page, you may be asked to submit pictures of your display or wares.
- This event is rain or shine.
- Vendors must remove all trash and debris at the close of the event.
- Quiet hours start at 9PM each night.
- This is a family-oriented, community event. Displays and products should be appropriate for all ages. No profanity, suggestive language, or products supporting intolerance towards another group will be allowed.
- **Applications are due by September 8, 2026.**

Park Rules

- The sale or use of alcohol is not permitted at this event, unless sanctioned by the Morgan County Parks Department.
- Smoking is not allowed in any building or structure—including temporary structures during events.
- All pets must be leashed at all times and any waste must be immediately removed.
- Weapons, including firearms, are not to be used at the park, excepting historical reenactments during park-sponsored programs.
- Fireworks and other projectiles are not permitted.
- Parking is only permitted in designated areas.
- No fire building is permitted, except by permit of the Morgan County Parks Department.
